## Product Information

This glossy vinyl is a polypropylene film coated with a white gloss finish. It has a thickness of 60 microns and is **free from PVC**.

The film features a grey permanent adhesive for secure bonding. To facilitate easy installations, it is protected by a PE-coated air release liner weighing 135gsm.

This vinyl is well-suited for a variety of applications, both indoors and outdoors, including graphics, point-of-sale displays, exhibitions, and smooth surfaces.

It delivers vibrant and high-quality color prints with a glossy appearance. Moreover, it exhibits excellent dimensional stability, ensuring long-lasting results. For optimal outcomes, it is recommended to use this vinyl with Latex and UV printers.

## Shelf Life

1 year when stored in the original packaging between 20°C and 25°C at 50% relative humidity.

## Recommendations

Mounting to PVC substrates can cause the adhesive to transfer residue.

Please ensure the print is perfectly dry before laminating.

We suggest to let the material dry for at least 48 hours before after printing.
